

## Directions to Fun Test site:

The address is 675 N. Glenville Dr. #165, Richardson, TX (**do not send entry forms to this address**). Take US Hwy 75 (Central Expressway) to Arapaho Road in Richardson, East to Glenville Drive, South about 1000' to the Fun Test site.

Note that the Barn Hunt training area is behind (West of) the main WAGD facility - see the satellite photo below for the precise location.



Per Barn Hunt Association rules, bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their classes. There will be a sign indicating the BIS crating area. Entry fees for bitches that come into season will be refunded until the closing date of the fun test if you wish to withdraw. After the closing date, entry fees will not be refunded. If you bring a bitch in season, you **must** inform the trial committee prior to the fun test and you are requested to inform all exhibitors at the judges' briefings. Bitches in season must wear pants when running.

Open to all breeds and mixed breeds.

*Entries open on 3/1/2020 and close on 5/20/2020. Day-of-Show Entries will be available if the event has not filled. Late entries will be processed as day-of-show upon payment of the day-of-show entry fee at the trial site if the trial has not filled.*

Entry fees are \$10/run for all classes (pre-entry). Late or day of show entries: \$15/run.

Permission has been granted by the Barn Hunt Association, LLC for the holding of this Barn Hunt Fun Test under BHA Rules and Regulations.



## SPECIAL FUN TEST RULES

First of all, this is **not** a titling event. Think of it as a training opportunity! In addition, we will be helping Alison Bradley, a wonderful friend to our club, in her quest to fulfill the requirements to become a licensed Barn Hunt judge.

Second: dogs are **not** required to be registered with Barn Hunt LLC. Any dog may participate! Dogs may also be entered in any class, any number of times. It's totally up to you.

You may train in the ring! You can either declare this to the judge, or the judge will make a determination that you're training and will direct the scribe to indicate this on your scribe sheet. If training in the ring, you and your dog may do whatever you like for the duration of the standard course time, within the boundaries of the standard Barn Hunt rules of sportsmanship and safety. You may bring non-crumbley treats and/or toys into the ring with you. If you wish, the judge will point out rat hides to you.

You may leave your dog on collar/harness (no tags or other dangly things) and leash if you wish. You may also carry your leash into the ring with you. Dogs wearing a collar or harness must also be on leash. Dogs on leash are not to be asked to tunnel. See the rule books at barnhunt.com for complete rules.

**Note:** you may fill your entry form out online by clicking on "create mail in entry" at the event link on barnhunt.com. Be sure to click the "I understand" box and print your entry out (use the "print" button right under the box) before mailing it in.

In addition, we are now taking online entries via Wufoo. Here's the link:

Note that there is a \$5.00 per dog service charge for using the Wufoo link, but you don't have to print anything or find a stamp. **We prefer entries via Wufoo or barnhunt.com. Illegible entries may be rejected.**

A wait list will be maintained. Entrants who withdraw after the closing date will receive a refund only if there is an entrant on the wait list who can take their place.

Day-of-show entry will be available if the trial has not filled. Day-of-show will be taken from 7:00-7:30 AM.

## EXHIBITOR INFORMATION

All dogs must be kept on a short leash and under control while on trial grounds except when showing. Electronic collars and head halters are not permitted. No dog may be at any time tied out or otherwise attached to anything other than a human. There is no smoking allowed inside the building, and no alcohol allowed anywhere at the facility. **Handlers who fail to pick up after their dogs may be excused.**

### Running order:

Dogs will be run in height order with dogs being handled by the same person separated into different staged groups. Master will be run in blinds of four dogs; all other classes in blinds of five. **All requests for running order changes must be approved by the Blind Steward.**

**Class order:** Instinct, Senior, Novice, Master, Open, Crazy 8s

### Awards:

All entered dogs will receive a special ribbon thanking them for participating in the fun test. No placement or qualifying ribbons will be awarded.

Ribbons for special awards may be available. If you would like to sponsor a special award, please contact the Trial Chair.

Please bring adequate food for your dogs. There is water on-site, and there are several fast-food restaurants nearby. There are indoor restrooms on site.
